

## MINUTES

### BOARD OF COMMISSIONERS OF THE MAGISTRATES RETIREMENT FUND OF GEORGIA

Monday, August 15, 2016

Griffin, Georgia

A regular meeting of the Board of Commissioners of the Magistrates Retirement Fund of Georgia was held on Monday, August 15, 2016 at 10:00 a.m. at the Peace Officers' Annuity and Benefit Fund of Georgia located in Griffin, Georgia.

#### I. CALL TO ORDER

A. Judge Tommy Bobbitt, Chairman, called the meeting to order at 10:00 a.m. The following is a listing of all persons present at the meeting:

#### II. APPROVAL OF MINUTES

##### A. Minutes

- i. Board Members reviewed the minutes from the May 16, 2016 Board Meeting. Judge Holt made a motion to approve the minutes. It was seconded by Judge Cavanaugh, and the minutes were unanimously approved.

#### III. REPORTS BY OFFICERS AND COMMITTEES

- A. James Fallon and Chad Smith of Morgan Stanley were present and introduced to the Board proposed new managers:
  - a. Atlanta Capital Management
  - b. Columbia Threadneedle Investments
  - c. Brandes Investment Partners
  - d. Lazard Asset Management
  - e. Sage
  - f. Western Asset Management

Following a lengthy and in-depth discussion and recommendations from Advisors Jim Fallon and Chad Smith, the following motions were made:

A motion was made by Judge Holt, and seconded by Judge Anderson, to liquidate 100% of the Index Fund and place assets with Sage; and authorize Secretary/ Treasurer Robert Carter to execute all documentation to complete the transfer of funds. The vote was unanimous.

A motion was made by Judge Holt, and seconded by Judge Cavanaugh, to transfer the Large Cap Core Funds to Atlanta Capital, terminate the contract with BMO; and authorize Secretary/ Treasurer Robert Carter to execute all documentation to complete the transfer of funds. The vote was unanimous.

A motion was made by Judge Holt, and seconded by Judge Anderson, to liquidate the International Core Equity Index Funds, transferring from BMO to Lazard; and authorize Secretary/ Treasurer Robert Carter to execute all documentation to complete the transfer of funds. The vote was unanimous.

Mr. Carter noted the Small Cap, low volatility funds would remain with BMO.

Chad Smith and James Fallon presented a detailed report of the Magistrates Retirement Fund portfolio for the Quarter ending June 30, 2016.

#### B. Financial Report

- i. Mr. Carter presented the Financial Report and the Membership Report. Judge Holt made a motion to accept both reports. Judge Anderson seconded the motion and it was unanimously approved.

Mr. Carter proposed a possible Board Planning Workshop in the future to discuss the upcoming 2017 Legislative Session.
